Commercial Booths in the Assembly Hall may set up on Thursday, beginning at 10:00 a.m. (any one with special needs should set up on Wednesday so that they may be addressed) Nothing may be sold, given away, or otherwise disposed of by an exhibitor without approval. Booths must be kept attractive and fit in space designated on the application.

#### No merchandise deemed obscene by fair management will be allowed.

Assembly Hall hours Friday 5:00 p.m. - 11:00 p.m., Saturday 12:00pm. -11:00pm, Sunday 12:00pm. -11:00 p.m. All booths must be open during these hours. <u>Times are subject to change</u>.
